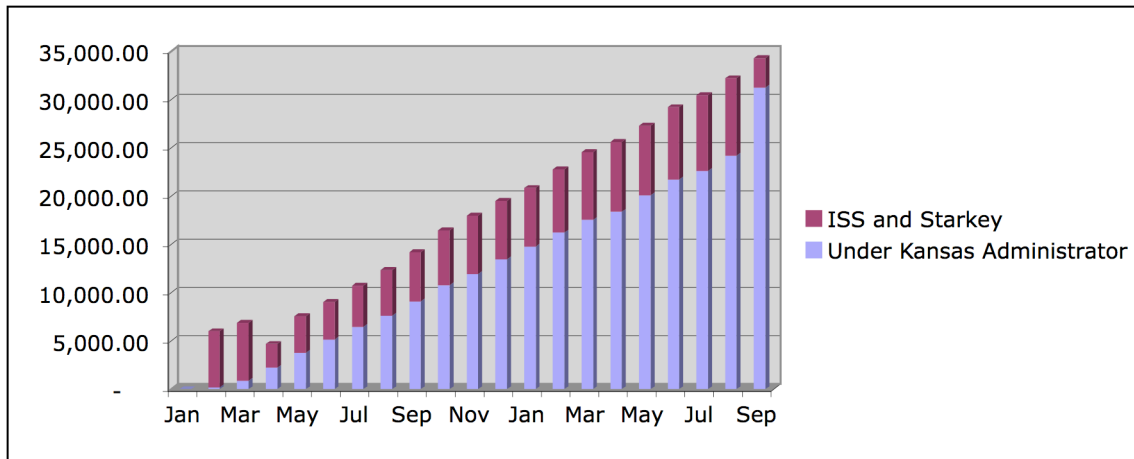
- ISS moved learners to the state site. Learners have been included in Under the State Administrator.

Activities

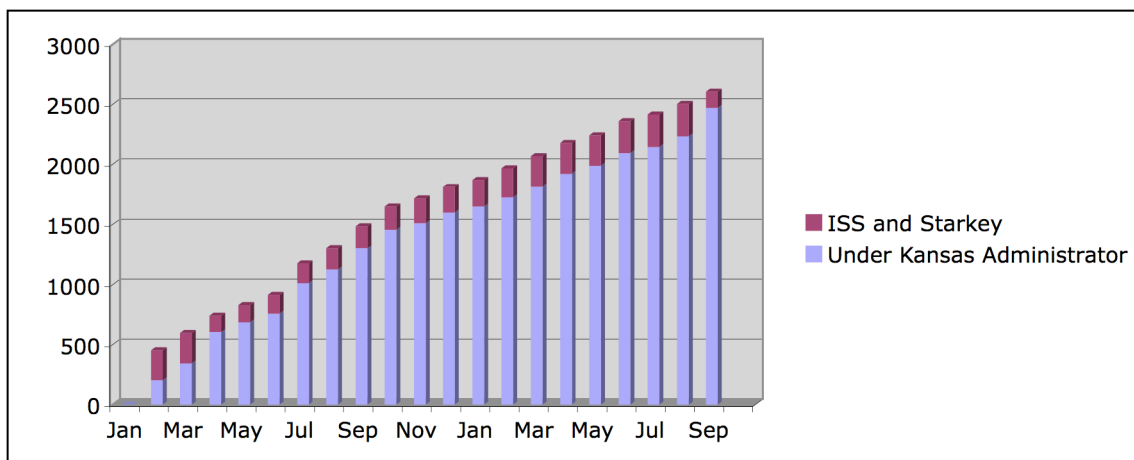
- Regional Sharesops for CDS administrators have been scheduled for September 4th, 11th, and 26th.
